DIANA SHIPPING INC. ANNOUNCES THE ACQUISITION  
OF A PANAMAX DRY BULK CARRIER

ATHENS, GREECE, November 18, 2011 – Diana Shipping Inc. (NYSE: DSX), a global shipping company specializing in the ownership and operation of dry bulk vessels, today announced that it has agreed to purchase from an unaffiliated third party the MV “Vathy”, a 2010 built Panamax dry bulk carrier of 81,297 dwt, for a price of US\$32.25 million. The vessel, to be renamed “Leto”, is expected to be delivered to the Company by the sellers during the first quarter of 2012.

2011 ANNUAL MEETING OF SHAREHOLDERS

(NYSE: DSX), a global shipping company specializing in the ownership and operation of dry bulk vessels, announced today that the Company's Annual Meeting of Shareholders was duly held on November 16, 2011, in Amsterdam, The Netherlands pursuant to a Notice of Annual Meeting of Shareholders dated October 7, 2011. Broadridge Financial Solutions, Inc. acted as inspector of the Meeting.

At the Meeting, each of the following proposals, which are set forth in more detail in the Notice of Annual Meeting of Shareholders and the Company's Proxy Statement sent to shareholders on or around October 7, 2011, were approved and adopted:
