DIANA SHIPPING INC. ANNOUNCES DIRECT CONTINUATION OF TIME CHARTER CONTRACT FOR M/V ALIKI WITH SWISSMARINE

ATHENS, GREECE, February 10, 2017 – Diana Shipping Inc. (NYSE: DSX) (the "Company"), a global shipping company specializing in the ownership of dry bulk vessels, today announced that, through a separate wholly-owned subsidiary, it has agreed to extend the present time charter contract with SwissMarine Services S.A., Geneva, for one of its Capesize dry bulk vessels, the m/v Aliko, for a period of about eleven (11) months to maximum fourteen (14) months. The gross charter rate is US\$10,300 per day, minus a 5% commission paid to third parties. The new charter period is expected to commence on February 13, 2017.

The "Aliko" is a 180,235 dwt Capesize dry bulk vessel built in 2005.

The employment extension of "Aliko" is anticipated to generate approximately US\$3.24 million of gross revenue for the minimum scheduled period of the time charter.

Diana Shipping Inc.'s fleet currently consists of 48 dry bulk vessels (4 Newcastlemax, 14 Capesize, 3 Post-Panamax, 4 Kamsarmax and 23 Panamax). As of today, the combined carrying capacity of the Company's fleet is approximately 5.7 million dwt with a weighted average age of 7.70 years. Diana Shipping Inc. is a global provider of shipping transportation services through its ownership of dry bulk vessels. The Company's vessels are employed primarily on medium to long-term time charters and transport a range of dry bulk cargoes, including such commodities as iron ore, coal, grain and other materials along worldwide shipping routes.
