On February 6, 2015, the issuer declared a cash dividend of \$0.11 per share of common stock, payable March 27, 2015 to all shareholders of record on March 13, 2015 (the "Dividend"). In accordance with the terms of the Restricted Stock Agreements dated January 2, 2013, January 2, 2014, August 25, 2014 and January 2, 2015, 242, 95, 154 and 297 additional shares of restricted stock were received by the reporting person in connection with the Dividend, respectively. The additional shares of restricted stock will vest as follows: 242 shares in even increments over 3 years beginning January 2, 2016, 95 shares in even increments over 4 years beginning January 2, 2016, 154 shares in even increments over 5 years beginning August 25, 2015 and 297 shares in even increments over 5 years beginning January 2, 2016.
