On October 30, 2015, the issuer declared a cash dividend of \$0.12 per share of common stock, payable December 24, 2015 to all shareholders of record on December 11, 2015 (the "Dividend"). In accordance with the terms of the Restricted Stock Agreements dated January 2, 2013, January 2, 2014, August 25, 2014 and January 2, 2015, 59, 57, 143 and 160 additional shares of restricted stock were received by the reporting person in connection with the Dividend, respectively. The additional shares of restricted stock will vest as follows: 59 shares in even increments over 3 years beginning January 2, 2016, 57 shares in even increments over 4 years beginning January 2, 2016, 143 shares in even increments over 4 years beginning August 25, 2016 and 160 shares in even increments over 5 years beginning January 2, 2016.
