### Preliminary Terms

**Issuer:** Citigroup Global Markets Holdings Inc.  
**Guarantor:** Citigroup Inc.  
**Underlying index:** The S&P 500® Index (ticker symbol: "SPX")  
**Pricing date:** April 25, 2019  
**Valuation date:** April 25, 2022  
**Maturity date:** April 28, 2022  
**Payment at maturity:** For each note you hold at maturity, the \$1,000 stated principal amount *plus* the note return amount, which will be either zero or positive  
**Note return amount:** If a knock-out event occurs: \$1,000 × the knock-out return  
 If a knock-out event does not occur: \$1,000 × the absolute value of the index return  
**Knock-out return:** 3%  
**Knock-out event:** A knock-out event will occur if the closing level of the underlying index on any scheduled trading day during the observation period is less than the downside knock-out level or greater than the upside knock-out level  
**Observation period:** The period from but excluding the pricing date to and including the scheduled valuation date  
**CUSIP / ISIN:** 17326YLR5 / US17326YLR52

### Key Definitions

**Upside knock-out level:** 124% to 126% of the initial index level\*  
**Downside knock-out level:** 74% to 76% of the initial index level\*  
**Initial index level:** The closing level of the underlying index on the pricing date  
**Final index level:** The closing level of the underlying index on the valuation date  
**Index return:** (i) The final index level *minus* the initial index level, *divided by* (ii) the initial index level  
 \* The actual upside knock-out level and downside knock-out level will be determined on the pricing date
