Application Submitted for Commencement of Corporate Rehabilitation Proceedings by Huis Ten Bosch Co., Ltd: Eventual possibility of credit losses

Tokyo, February 26, 2003---Mitsubishi Tokyo Financial Group, Inc. (MTFG; President: Shigemitsu Miki) announced today that credit provided by its subsidiaries The Bank of Tokyo-Mitsubishi, Ltd. (BTM) and The Mitsubishi Trust and Banking Corporation (MTBC) to Huis Ten Bosch Co., Ltd. (Huis Ten Bosch) eventually may not be repaid due to the event described hereunder.
