As of the date of this filing, Integrated Core Strategies (US) LLC, a Delaware limited liability company ( Integrated Core Strategies ), may be deemed to be the beneficial owner of 1,460,631 shares of Common Stock. Integrated Core Strategies also holds 7,208,600 warrants of the Company ( Warrants ). Each Warrant entitles the holder to purchase one share of the Company s Common Stock at a price of \$5.00. Each Warrant will become exercisable on the later of the Company s completion of a business combination and January 29, 2008, and will expire on January 28, 2011, or earlier upon redemption. In certain cases, the Warrants and Common Stock are part of the Company s units.

Also, as of the date of this filing Millenco LLC, a Delaware limited liability company ( Millenco ) (formerly known as Millenco, L.P.), has ceased to be the beneficial owner of any shares of Common Stock.

Millennium Management LLC, a Delaware limited liability company ( Millennium Management ), is the general partner of Integrated Holding Group LP, a Delaware limited partnership ( Integrated Holding Group ), which is the managing member of Integrated Core Strategies and consequently may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies. Israel A. Englander ( Mr. Englander ) is the managing member of Millennium Management. As a result, Mr. Englander may be deemed to have shared voting control and investment discretion over securities deemed to be beneficially owned by Millennium Management.
