Series E on July 25, 2008  
Series F on July 30, 2008

(3) Applicable provisions of the governing instrument pursuant to which the securities are to be redeemed:

APS are to be redeemed in accordance with Section 3 of the Certificate of Vote of Trustees Establishing Six Series of Preferred Shares.

(4) The principal amount or number of shares and the basis upon which the securities to be redeemed are to be selected:

Van Kampen Municipal Opportunity Trust intends to redeem the following:

600 outstanding shares of Series A APS  
600 outstanding shares of Series B APS  
400 outstanding shares of Series C APS  
400 outstanding shares of Series D APS  
400 outstanding shares of Series E APS  
320 outstanding shares of Series F APS
