FREMANTLE EXERCISES CONVERSION RIGHT TO ACQUIRE 2.9 MILLION PEACE ARCH SHARES

TORONTO, ONT. - Peace Arch Entertainment Group Inc. (AMEX and TSX: PAE), announced today that FremantleMedia (Fremantle) has agreed to convert its \$8,793,375 note plus interest in the company for 2,931,125 shares of Peace Arch common stock. Under a January 2003 debt restructuring agreement between Fremantle and the Company, Peace Arch had previously provided for the issuance of these shares in June 2004.

Gary Howsam, Peace Arch's CEO, commented: We are very pleased that a global media giant like Fremantle has chosen to convert debt into Peace Arch equity.

Peace Arch Entertainment Group Inc. (www.peacearch.com) develops, produces, acquires and licenses feature films and television programming to theatrical, home video and television distributors throughout the world. Peace Arch's current feature projects include the recently completed *Shadows in the Sun* starring Harvey Keitel, Joshua Jackson and Claire Forlani, the critically acclaimed *The Good Shepherd* and *Our Fathers*, the first of an anticipated 15 films to be produced by Peace Arch and Showtime pursuant to a long term co-production agreement between the two companies. Through its subsidiary, The Eyes Project Development Corp., Peace Arch produces episodic lifestyle television series such as the award-winning *Campus Vets* and the popular home makeover show *Love It or Lose It*, along with celebrated documentaries like *Prisoners of Age*. Peace Arch Entertainment Group Inc. and its subsidiaries have offices in Toronto, Vancouver, Los Angeles and London, England.

FremantleMedia (www.fremantlemedia.com) is the content business production arm of the RTL Group, Europe's largest television and radio broadcast company, with interests in 31 television channels and 30 radio stations in ten European countries. RTL Group is 90% owned by Bertelsmann AG, an integrated media and entertainment company that commands leading positions in the world's major media markets. Fremantle is one of the largest creators and producers of program brands in the world, with leading prime time drama, serial drama, entertainment and factual entertainment programming in around 40 territories including the UK, the US, Germany, Australia, France, Italy, Spain, Portugal, Scandinavia, Latin America and Asia

A.

Rule as to Use of Form 6-K,
