  - (1) Represents the purchase of 62,002 shares in [ 288 ] separate transactions, ranging in price from \$5.12 to \$5.52, resulting in a weighted average purchase price per share of \$5.3611. The reporting person will provide, upon request by the SEC staff, the Issuer or a security holder of the Issuer, full information regarding the number of shares purchased at each separate price within the range.
  - (2) Represents the purchase of 38,398 shares in [ 200 ] separate transactions, ranging in price from \$5.44 to \$5.89, resulting in a weighted average purchase price per share of \$5.7153.
