This Amendment No. 1 amends the original Schedule 13D ("Schedule 13D") previously filed by Red Mountain Resources, Inc. ("Red Mountain"), Black Rock Capital, Inc. ("Black Rock") and Alan W. Barksdale ("Barksdale") with respect to ownership of the common stock, par value \$0.001 per share ("Common Stock"), of Cross Border Resources, Inc., a Nevada corporation (the "Issuer"). Unless set forth below, all previous Items are unchanged. Capitalized terms used herein which are not defined herein have the meanings given to them in the Schedule 13D, as amended, previously filed with the SEC.

The percentage of beneficial ownership reflected in this Schedule 13D is based upon 16,151,946 shares of Common Stock outstanding as of August 8, 2011.

Item 3. Source of Funds or Other Consideration.

Item 3 of the Schedule 13D is hereby amended to add the following:

On August 16, 2011, Red Mountain purchased an additional 218,535 shares of the Common Stock of the Issuer in exchange for the issuance of 273,169 shares of Red Mountain's common stock.

Item 5. Interest in Securities of the Issuer.

Item 5 of the Schedule 13D is hereby amended in its entirety to read as follows:

Each of Red Mountain and Barksdale is deemed to be the beneficial owner of 2,354,699 shares of the Issuer's Common Stock, or approximately 14.6% of the Issuer's outstanding Common Stock. This represents 218,535 shares of Common Stock held by Red Mountain and 2,136,164 shares of Common Stock held by Black Rock, Red Mountain's wholly owned subsidiary. Black Rock is deemed to be the beneficial owner of 2,136,164 shares of the Issuer's Common Stock held by it. Does not include warrants to purchase 2,136,164 shares of Common Stock of the Issuer held by Black Rock which are not exercisable and will not become exercisable within 60 days. Barksdale is the Chief Executive Officer of Red Mountain and an officer of Black Rock. As such, Barksdale has the authority to vote the shares of Common Stock on behalf of Red Mountain and Black Rock.

In the past 60 days, Red Mountain effected the transaction described under Item 3 above and such transaction is incorporated by reference herein.
