## BRIEF EXPLANATION

International crude oil price remained low in July 2016. The Company strengthened its marketing efforts based on market demand. This month, passenger capacity of the Company increased by 10.7% as compared to the same period last year and passenger load factor was 82.6%, representing an increase of 0.8 percentage point as compared to the same period last year. The overall balance between supply and demand was maintained.

Due to the increase in the overall bellyhold cargo capacity, the freight transportation capacity of the Company increased by 9.3% year-on-year. Freight traffic volume increased by 9.7% year-on-year, while freight load factor was

51.8%.
