## Item 1.01. Other Events. Entry into a Material Definitive Agreement.

On September 6, 2017, Builders FirstSource, Inc. (the Company ) entered into an underwriting agreement (the Underwriting Agreement ), among the Company, Goldman Sachs & Co. LLC, as underwriter (the Underwriter ), and JLL Building Holdings, LLC, as a selling stockholder (the Selling Stockholder ).

Pursuant to the Underwriting Agreement, subject to the terms and conditions expressed therein, the Selling Stockholder agreed to sell to the Underwriter an aggregate of 13,482,177 shares of the Company s common stock (the Securities ) at a price of \$16.17 per share.

The Securities are being sold by the Selling Stockholder pursuant to a preliminary prospectus supplement, dated September 6, 2017, a final prospectus supplement, dated September 6, 2017 and the related prospectus dated November 26, 2014, each filed with the Securities and Exchange Commission, relating to the Company s registration statement on Form S-3 (File No. 333-199955), as amended by Pre-Effective Amendment No. 1 thereto.

The Company has agreed to indemnify the Underwriter against certain liabilities, including certain liabilities under the Securities Act of 1933, as amended. If the Company is unable to provide the required indemnification, the Company has agreed to contribute to payments the Underwriter may be required to make in respect of those liabilities. In addition, the Underwriting Agreement contains customary representations, warranties and agreements of the Company and the Selling Stockholder and customary conditions to closing. The offering closed on September 8, 2017.
