Disposed of pursuant to the Agreement and Plan of Merger, dated as of June 27, 2008, by and among Darwin Professional Underwriters, (1) Inc. (the "Company"), Allied World Assurance Company Holdings, Ltd and Allied World Merger Company (the "Merger Agreement"), in exchange for a cash payment of \$32.00 per share of the Company's common stock (the "Common Stock") held by the reporting person.

These share units were credited to the Reporting Person under the Company's Stock and Unit Plan for Non-employee Directors (the (2) "Plan") and were to have vested in future years, but became immediately vested upon the "change of control" effected under the Merger Agreement and immediately converted into the right to receive \$32 per stock unit.
