Holding Company LLC, WGR Holdings, LLC ("WGR Holdings"), Western Gas Holdings, LLC (the "General Partner"), WES GP, Inc., Western Gas Partners, LP (the "Partnership"), Western Gas Operating, LLC and WGR Operating, LP, the Partnership acquired a 24% interest in Chipeta Processing LLC for aggregate consideration of approximately \$135 million. The consideration consisted of \$128,250,000 in cash, 151,235 common units of the Partnership issued to WGR Holdings and 3,086 general partner units of the Partnership issued to the General Partner.

- (2) As of August 1, 2012, (i) WGR Holdings owns 99% of the membership interests in the General Partner, (ii) WGR owns all of the membership interests of WGR Holdings and (iii) Anadarko Petroleum Corporation ("Anadarko") owns all of the issued and outstanding shares of common stock of WGR. Accordingly, WGR and Anadarko may be deemed to be indirect beneficial owners of any securities held by WGR Holdings.
