- (1) The restricted stock units granted on May 7, 2015 will vest 100% at the anniversary of the grant date. This is an annual non-employee director grant as outlined in the 2015 proxy.
- Mr. Beard has been granted a total of 18,000 shares in two grants; (A) 10,000 RSUs granted May 8, 2014 which vest annually in 4 equal installments on each anniversary of the grant date until fully vested; (B) 8,000 RSUs granted 5/7/2015 which vest 100% at the anniversary of the grant date. December 8, 2014 he purchased 10,000 shares as part of a 10b5-1 plan. As of the reporting date, the RSUs are unvested and he holds 12,500 shares in street name.
