## Explanation of Responses:

(1) This transaction represents the settlement of vested performance stock units in shares of common stock. These were performance stock units granted on 8/23/13 that vested on 7/1/16 and were paid in shares of common stock on 8/26/16. Each performance stock unit represents a contingent right to one share of the Issuer's common stock. The performance stock unit grant was previously reported.

(2) Increase in vested performance stock units granted 8/23/2013 based upon performance stock unit payout formula resulting in an additional payment in shares of common stock on 8/26/16.

(3) Shares withheld by company to pay tax liability on vesting of performance stock units previously awarded.

(4) Aggregate of 54,127,20 shares listed in Column 5 of Table I includes 6,275 restricted shares previously reported.

(5) Of the 45,680 options granted on this 8/26/16 stock option, 15,227 options become exercisable on 8/26/17, an additional 15,227 options become exercisable on 8/26/18, and the remaining 15,226 options become exercisable on 8/26/19.

(6) Each performance stock unit represents a contingent right to one share of the Issuer's common stock. Performance stock units are subject to future adjustment; performance period started 7/2/16. The 7,055 performance stock units will vest on 6/28/19. Vested shares are subject to future adjustment and will be delivered to the reporting person within two and one-half months of vesting.
