The Restricted Stock Units ("RSUs") granted on 02/13/2015 vest 25% on each of the first four anniversaries of the date of grant. 402 RSUs, that included accrued dividend equivalents, vested on 02/13/2017 and were paid out in the form of Republic Services, Inc.'s common stock.
