- Each restricted stock unit represented a contingent right to receive one share of Emcore common stock. Restricted stock units were
- (1) payable, at the election of the Issuer, in cash, Emcore common stock, or a combination of the two. On January 30, 2013, the Issuer settled the restricted stock units in common stock.
 - (2) Includes 12,500 shares of restricted stock granted under the Company's 2010 Equity Incentive Plan, vesting on January 28, 2014.
 - (3) All sales were effected pursuant to a 10b5-1 plan previously adopted by the Reporting Person to satisfy the Reporting Person's tax liability in connection with the vesting of shares of restricted stock that were granted under the Company's 2010 Equity Incentive Plan, which grant was exempt from Section 16b pursuant to Rule 16b-3(d).
 - (4) Reflects aggregate reporting of multiple open market transactions. The price reported is the weighted average sale price of sales ranging from \$5.59 to \$5.61 per share.
