Based on information that is available at this time, the Company's net income from operations for the three months ended March 31, 2014 is expected to be in the range of approximately \$0.8 million to \$1.2 million, compared to net income from operations of approximately \$1.8 million for the three months ended March 31, 2013. This change is largely the result of an increase in revenues of approximately \$0.2 million, lower general and administrative costs of

approximately \$0.1 million, and an increase in depletion expense of approximately \$0.1 million. Further, during the three months ended March 31, 2013 the Company recorded a gain on settlement of debt of approximately \$0.9 million while no such gain will be recorded during the three months ended March 31, 2014. The Company cautions that the estimation of net income from operations is preliminary and subject to change, possibly materially, following the completion and review of the Company's financial statements.
