Item 8.01. Other Events.

The Board of Directors of National Bank Holdings Corporation (the "Company") has authorized a new program to repurchase up to \$50.0 million of the Company's common stock from time to time either in the open market or in privately negotiated transactions in accordance with applicable regulations of the Securities and Exchange Commission. The Company completed its previously authorized \$50.0 million stock repurchase program announced in July 2014, repurchasing 2.5 million shares.

Since early 2013, the Company has repurchased 12.5 million shares, or 23.9% of its outstanding shares, at a weighted average price of \$19.73 per share. As of October 20, 2014, the Company had outstanding 39,867,040 shares of its common stock, including 38,999,266 shares of Class A voting common stock and 867,774 shares of Class B non-voting common stock.
