1,200,000 of the Reported Shares are held by the Hodges Fund and 143,400 of the Reported Shares are held by the Hodges Pure Contrarian Fund, both of which are series of Professionally Managed Portfolios, an investment company registered under the Investment Company Act of 1940. The investment adviser to both of these funds is HCM, which may be deemed to be a beneficial owner of the funds' Reported Shares.
