Mr. Radford was awarded (i) 137,295 restricted stock units on July 1, 2015; (ii) 78,409 restricted stock units on June 7, 2016; and (iii)

- (1) 58,773 restricted stock units on June 7, 2017. The restrictions lapsed on 1/3 of these vesting units (91,492 shares). Mr. Radford elected to have Hecla Mining Company withhold 42,773 shares to cover his tax liability.

- (2) Total consists of 550,046 shares held directly and 182,811 unvested restricted stock units.
