Pursuant to Company policy, market sales of Company stock by officers and directors are permitted only after the second full trading day

- (2) Restricted shares granted under the NIKE, Inc. 1990 Stock Incentive Plan. The restrictions lapse with respect to one-third of the shares on each of the first three anniversaries of the grant date; and upon any termination of employment, any shares as to which the restrictions have not expired shall be forfeited to NIKE for cancellation and become authorized but unissued shares.

- (3) Includes 67,666 restricted shares granted under the NIKE, Inc. 1990 Stock Incentive Plan.

- (4) Shares held in account under NIKE, Inc. Employee Stock Purchase Plan.

- (5) Shares held in account under the NIKE, Inc. 401(k) and Profit Sharing Plan.

- (6) Option Granted on 07/15/2011 and becomes exercisable with respect to 25% of the shares on each of the first four anniversaries of the date of the grant.
