Mr. Hadrill's distribution includes the vesting of 11,312 RSUs based upon the achievement of certain strategic business objectives in 2016 and 45,249 RSUs based upon the achievement of a 2016 revenue objective. 56,561 of the RSUs that remain outstanding are scheduled to vest in 2018, subject to satisfaction of certain performance criteria, 45,249 of which may vest at up to 200%, and 169,683 of the RSUs that remain outstanding are scheduled to vest in 2018, one half of which may vest at up to 200% and the other half at up to 115%, both subject to satisfaction of certain other performance criteria.
