On April 17, 2019, we executed and delivered an OmniAb platform license agreement with a Bay area venture-stage biotechnology company. Under the license, they will be able to use OmniAb ${ }^{\circledR}$ platform rodents and birds in campaigns to discover fully human mono- and bispecific antibodies.

We are receiving an upfront payment and we are eligible to receive development and commercial milestone payments and royalties for each product incorporating an OmniAb antibody. They will be responsible for all costs related to the programs.

OmniAb ${ }^{\circledR}$ is a three-species transgenic-animal platform consisting of four different technologies used for producing mono- and bispecific human therapeutic antibodies. OmniRat ${ }^{\circledR}$ transgenic rats embody the industry's first human monoclonal antibody technology in rats. OmniRat animals have a complete immune system with a diverse antibody repertoire and generate antibodies with human idiotypes as effectively as wild-type animals make rat antibodies. OmniMouse ${ }^{\circledR}$ is a transgenic mouse that complements OmniRat and expands epitope coverage. OmniFlic ${ }^{\circledR}$ is an engineered rat with a fixed light chain for development of bispecific, fully human antibodies. OmniChicken ${ }^{\mathrm{TM}}$ chickens have been genetically modified to have the immunoglobulin genes replaced with corresponding human genes, and embody the industry's first human monoclonal antibody technology in chickens. The four technologies use patented technology, have broad freedom to operate and deliver fully human antibodies with high affinity, specificity, expression, solubility and stability.
