On October 21, 2004, Mr. Farahi was granted an option pursuant to the Company's 1993 Executive Long-Term Incentive Plan, as amended, to purchase 50,000 shares of the Company's common stock at \$23.37 per share. The shares will vest as follows: 16,666 shares on October 21, 2005; 16,666 shares on October 21, 2006; 16,667 shares on October 21, 2007.
