Explanation of Responses:

(1) Mr. Morgan entered into a prepaid variable share forward arrangement (the "Transaction") with an unrelated third party (the "Buyer") relating to 30,000 shares of common stock of Celgene Corporation ("Common Stock"). The Transaction is scheduled to settle on March 5, 2009 (the "Settlement Date"). The Transaction specifies a forward floor price of \$52.85252 per share and a forward cap price of \$74.12566 per share.

(2) On the Settlement Date, Mr. Morgan will deliver to the Buyer (i) if the settlement price is less than the forward floor price, 30,000 shares; (ii) if the settlement price is greater than or equal to the forward floor price, but less than or equal to the forward cap price, a number of shares equal to the product of (A) 30,000 and (B) the forward floor price divided by the settlement price; and (iii) if the settlement price is greater than the forward cap price, a number of shares equal to the product of (A) 30,000 and (B) the quotient of (x) the forward floor price plus the excess of the settlement price over the forward cap price and (y) the settlement price.

(3) In lieu of delivering shares, Mr. Morgan may elect to settle the Transaction on the Settlement Date for cash. Mr. Morgan will receive a prepayment from the Buyer in the amount of \$1,284,316.24 on March 6, 2007 in connection with entering the Transaction. Mr. Morgan has pledged 30,000 shares of Common Stock to secure his obligations under the Transaction.
