On August 3, 2006, the Company announced its financial results for the first quarter ended June 30, 2006, which were furnished as an attachment to the Company s Form 8-K filed on August 3, 2006. The Company will be revising these previously announced financial results, which will be reflected in its Form 10-Q filing for the quarter ended June 30, 2006. The Company expects to record a cumulative compensation expense of \$703,000, net of tax, in the first quarter of fiscal year 2007 to correct identified accounting errors associated with options granted primarily to certain non-executive new hire employees during the ten-year period from the Company s initial public offering in December 2006 to June 30, 2006. There is no impact on revenue or net cash from operating activities as a result of recording the compensation expense.
