Item 2.01. Completion of Acquisition or Disposition of Assets.

On November 19, 2010, a subsidiary of Pebblebrook Hotel Trust (the Company) completed its acquisition of the 310-room Sheraton Delfina Santa Monica, California, hotel for \$102.8 million from Regis Properties LLC, an unaffiliated third party. The hotel will be managed by Viceroy Hotel Group (Viceroy) pursuant to a management agreement between the Company s taxable real estate investment trust subsidiary and Viceroy. The management agreement is for a 10-year term and provides for base management fees and incentive management fees within the ranges described in the Company s final prospectus for its public equity offering filed with the Securities and Exchange Commission pursuant to Rule 424(b) under the Securities Act of 1933, as amended (the Securities Act) on July 23, 2010. The management agreement also provides for termination at the Company s option at any time, and without cause, by giving written notice and paying a termination fee. In addition, the agreement contains other terms and provisions customarily found in hotel management agreements. The transaction was funded entirely with available cash.

The Company issued a press release on November 22, 2010 announcing that it had closed on the previously announced acquisition of an upscale, full-service hotel in the Los Angeles, California metropolitan region, the Sheraton Delfina Santa Monica hotel.
