#### DEREGISTATION OF UNSOLD SECURITIES

This Post-Effective Amendment No. 2 to Form S-8 relates to the Registration Statement on Form S-8 (333-83581), filed with the Securities and Exchange Commission on July 23, 1999 (the Registration Statement ) by Ciena Corporation, a Delaware corporation (the Company ), relating to 755,356 shares of the Company s common stock, par value \$0.01 per share ( Common Stock ), reserved for issuance under the Omnia Communications, Inc. 1997 Stock Plan, as Amended (the Plan ).
