On May 28, 2007, the Registrant completed the acquisition of a 51% ownership interest in ZAO Cortec and its subsidiaries (together Corbina ), a Russian telecommunications company. Due to the timing of the acquisition and the time required to prepare the consolidated financial statements of Corbina in compliance with generally accepted accounting principles in the United States, the Registrant and its auditors require more to time to complete the preparation and the quarterly review of the condensed consolidated financial statements of the Registrant. The Registrant anticipates filing its Quarterly Report on Form 10-Q by August 14, 2007.
